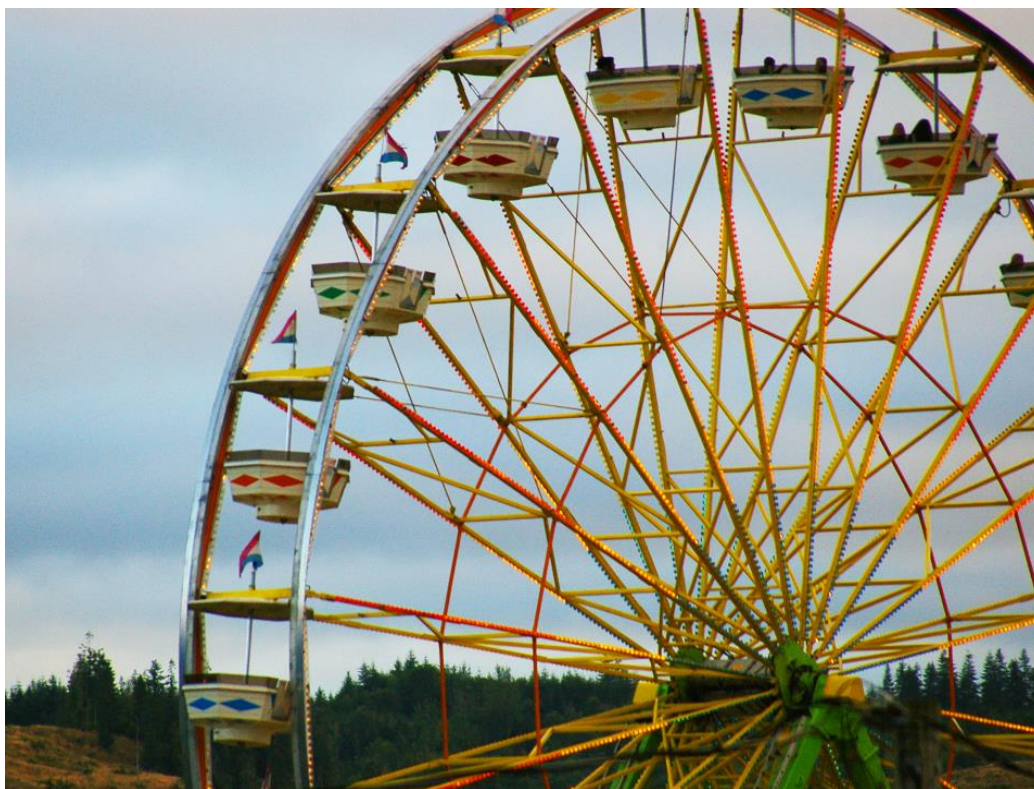

## **OCPA's New Equipment Tony Mason**

Back in November of '16, when we had to say goodbye to our long-time home at North Bend Medical Center. Not only did we need a meeting location (thank you to Hauser Community Church, then Pony Village Mall), we needed a screen to show images upon. So, for \$138 we purchased a 119-inch screen made by **ELite** (# T119UWS1).

Then, the Board decided (after a discussion that had been going on for what seemed like years), we purchased a **Epson 3700** Projector. (Thanks to Curt for researching the mindboggling projector variations.) \$1300 later, the new digital light emitting box became an immediate hit with a much brighter projection and higher resolution as it debuted in May. Granted, we are still learning how to set the optimum settings for our uses.

After another great Garage Sale last June, it was decided to go-ahead and get a new computer as both the laptop donated by Elise a few years ago, and my personal laptop that we've basically been using since we first started showing digital images way back when, are getting a little long-in-the-tooth. The basic criteria for a new machine was to have a dedicated graphic/video card, a minimum of 12 Gb of RAM, HDMI output, and fast processor. Plus, keep the whole purchase (including a UPS, uninterruptible power supply) under \$1000. The researching of thousands of computer combinations basically fell on me (with input from the rest of the Board).

A few weeks ago some emails started circulating between board members about some machines offered by Costco. Good choices & good prices, but I felt that if we were going to be spending a picture frame full of money on this computer, it should be something that will last many, many years; be upgradeable to give it longer life when needed; and be the latest tech. The

Costco machines were 2016 (on the higher end) down to around 2013 tech (thus the lower prices).

I found an 17" HP refurbished from Newegg for just short of \$800. I had a 7th gen i7 processor (2016, 2.7 Ghz, dual core), 1Tb HD, 16Gb DDR3 RAM and a NVidia 940MX GPU with 4Gb GDDR3. Pretty good, and with email communication, board approved. But since we are pushing our budget limit, I kept looking (Amazon, eBay, Staples, Best Buy, Lenovo, Acer, HP and some guy walking down the street).

Ending up at Dell (after viewing a video on YouTube), I found an Inspiration model that looked good. (no way we were going to spend 2-5 thousand on an Alienware). Of course, the base model may have worked, but digging through the configurations, I found one that had a 2017, 2.8 Ghz i7 quad-core (double the cores compared to the HP, a little faster and newer). 16Gb of RAM (same as the HP) but the newer DDR4 (faster) plus it was upgradable to a max of 32Gb (the HP was maxed at 16).

Both have 1920x1080 screens (the HP was 17.3", the Dell 15.6") & back-lit keyboards with numeric key pads. The Dell has a newer NVidia 1050Ti GPU (same 4Gb but with newer/faster GDDR5). Hard drives, the Dell has two: a 128Gb SSD for boot and programs, and a 1Tb for storage. The ports and conductivity were essentially on par between the two (but the HP did have an optical drive - but when was the last time you put in a CD/DVD? - they're going the way of the floppy disk).

So after some more back-and-forth emails, the Board decided these newer/faster features on the Dell were worth the \$300 higher price (\$1099.99 - normally \$1249.99) - plus it was a new machine rather than a referb. So I went ahead and ordered it...(<http://www.dell.com/en-us/shop/productdetails/inspiron-15-7567-laptop/dncwf510s>)

Smooth online process, got the order made, confirmation email received and all was right with the world. Then I checked one of my personal email accounts (there is a lesson to be learned here). A couple of years ago (when I bought my referb desktop from Dell), I signed up for their email sale notices. Since I just bought a machine, they never got looked at and trashed immediately. But I looked at this one... discount coupons! And they could be applied to the laptop I just bought seconds before! So back to the Dell website I go, and first confirmed that they had a price match guarantee. Then started an online chat with a Dell Rep (I don't like phones). Gave them the purchase number of the just bought laptop and the URL showing the lower price of the same machine. Very efficient/polite online rep. We had to cancel the first order (no charge), and then create a purchase order for the new one at the lower price. OK.

The internet is never fast enough. I kept checking email for the cancellation confirmation and the new purchase order. The order came through, but not the cancellation. I quickly looked over the order making sure it had the afore mentioned options, seemed in order. But I was not going to order another \$1000 item until I knew the first one was cancelled. Never got the email and the website still showed it as ordered. After waiting with a patient Rep, I finally decided to go-ahead and place the new order (unfortunately the instructions in the online chat was missing a decimal point in the order number I was supposed to enter, and after trying multiple times, the rep stating it was showing up on their end, I was getting frustrated (now pushing an hour on chat), I found the problem with the number in the email they sent (which I should have used to copy/paste instead of the chat version), and got in. Double checking the specifications I found a mistake on my part. I forgot to tell them which color I wanted (choice was black or red - I decided on red so it would stand out in a crowd). So, luckily, I had not yet clicked the "buy"

button. Let the Chat Rep know, and they sent a new purchase order via email. Now I knew what numbers to look for, where to enter them at, double checked the specs. and click... the bank account was drained. Big large sucking noise.

All was well. And it only took me how many words to tell you of this adventure (what else did I have to do while I poodle/house sat)? Oh, the discount made the price drop \$22 to \$1077.99 total shipped. But it is not over...

So with nothing else to do (other than having poodles on my lap), and now buyer's remorse starting setting in (did I get the best computer for the club's money, best features, etc.) - I once again started searching the internet for comparable machines. I came to the conclusion we got a reasonable price for comparable components. Yeah, we may save a couple more bucks here or there, but nothing significant for what we are getting.

Then it was back to YouTube with lap poodles and I searched for **Dell Inspiron 5767**. Dozens of reviews - of course most of them were based on using it for gaming. It is considered one of the best mid-price gaming machines on the market today (good, looks like I made a good choice), especially because of the graphics card, processor and ram (and great battery life). But then, almost all the videos started talking about how bad the monitor/screen/display was.

Bad viewing angle. Lousy brightness, contrast and color. In fact, it only displayed about 55% of the sRGB color space and somewhere around 35% of the Adobe RGB space. My heart fell to the floor, when I heard this from multiple reviewers. We wanted a machine for images, and the display was simply "not good" for this purpose. Because we would be plugging into the projector most of the time, this was not a deal breaker, but still... I felt I had made a bad choice.

But these reviews were all basically made right after this computer was released at the start of 2017. With a older tech TF display. They all wondered why Dell did not use the same IPS display they used on the older model. I don't have a clue what TF and IPS are. But all the internet seemed to agree, IPS is better (don't know what the %'s will be for color spaces, but IPS is the way to go). Some videos even showed how to buy a IPS display and change them out, the TF (or is it TN?) is just that bad.

"Panicking" I looked at the spec sheet for what we (I) just bought. IPS... we got a IPS. Looks like Dell started using these displays in late spring. We got the newest/greatest/bestest/badest mid-point machine.

Like everything, there is always something better on the other side of the fence if you got the money. If you have read this far, thank you for listing to my tales of woe and despair. And I guess I should mention we also bought a APS brand UPS 850VA/450W (mid-range) for \$79.99 from Amazon (Newegg was same price offering same \$10 coupon - Staples about \$20 higher, same with Best Buy, Wal-Mart, and eBay was basically full retail).

Next up: signing the club up for Adobe Creative Cloud subscription (PS & LR). But that will be in July so it will go on next year's expense report.



## **ANNUAL MEETING**

Elections, Potluck & Image Invitational Monday, July 10th, is our Annual Meeting which is the only meeting of the year that our membership is required to hold. This will be our 20th Annual Meeting, celebrating our 25th Anniversary. Some of the highlights of the meeting will be the “state of the club” presentation, our “normal” photo theme, after/before, 4Ws, critique and show/tell image viewing.

**Potluck Dinner:** everyone is encouraged to bring their favorite food dish to share with the membership (entrée, side or desert... or all of them, ha ha). You will need your own table service and drinks.

**Image Invitational:** all members are invited to participate in our first competition of the year.
