OCPA Board Meeting Minutes August 3, 2020

The Board met, via Zoom, within a month of the Annual Meeting, as required by the OCPA Bylaws.

The August 3rd, 2020 board meeting was called to order by President Carol Todd at approximately 4:00 pm. Board members present were: Carol Todd, Dick Chambers, Linda Petersen, Curt Benward, Don Todd, Elise Ciralo and Cathy Stevenson. Peggy Cooper was unable to participate. The following business was conducted at the meeting.

1. Approval of Board Minutes from May
The minutes were reviewed by the board, via email and published in the July newsletter.
2. Approval of OCPA Treasurer's Report
Linda Petersen gave the Treasurer's Report. Kathy Chambers paid the annual insurance premium of \$250 in July. The current balance in the OCPA account is \$2285.93.
3. Other business
 - a. OCPA Color Print Chair – The board will continue to recruit a new Color Print Chair, so that we are ready once face to face meetings and print competitions can resume.
 - b. 4Cs –
 - i. Elise C. agrees to cover the 4Cs Representative position, as Carol P. has resigned from that role.
 - ii. OCPA is recommending that the 4Cs Board continue to conduct most of their meetings online in the future. This would reduce travel costs for clubs and support more active participation.
 - iii. The issue of a judge exchange with other clubs for EID judging has been put forward by the 4Cs. The idea was discussed and tabled for now as EID competition is suspended during the pandemic.
4. Activities
 - a. The Board agreed to have a regular social gathering for club members. The club will meet for a picnic on the third Monday of each month at an outdoor location that allows for social distancing. Members should bring their own chairs, food and beverages. The August 17th picnic will be held at 12 noon in Ferry Park.
 - b. Chattergroup – The board agreed to allow spouses of OCPA members access to the Chattergroup.
 - c. Webinar- Carol Todd will be setting up a webinar with Lisa Langell. Members will be emailed a link to join the class.
 - d. Calendar – Carol T. asked board members to send additional ideas for the biweekly Theme Challenge, so she can complete and publish the annual calendar.

The meeting was adjourned at approximately 4:40 pm.
